

EUROPE PAYMENTS PERFORMANCE

D&B's payments performance data for the following selected countries depict the experiences of a range of independent, European companies that trade world-wide. Please note that data for these countries describe European and not US companies' payments experiences.

The left-hand side of the table indicates the percentage of payments reported to be made on time and within a given number of days beyond terms for the latest quarter available. The right-hand side of the table shows the recent trend in payments made 30 or more days over terms.
